Laws are not just about guaranteeing access to information, but provide the necessary accountability which should apply to governments, courts, the police, and other authorities which make critical decisions on behalf of people.

Currently, only 33 of the 54 Member States have national level right to information legislation in place. Bills drafted by either Governments or civil society advocates are pending in more than 09 countries across the Commonwealth from Barbados in the Caribbean to Papua New Guinea in the Pacific.

At a glance. Individuals have the right to access and receive a copy of their personal data, and other supplementary information. This is commonly referred to as a subject access request or 'SAR'. Individuals can make SARs verbally or in writing, including via social media. A third party can also make a SAR on behalf of another person.
