There are several 2020 CPT® code changes for the cardiovascular (CV) system; in the Category I section alone, there are 11 new codes, eight deletions, and two revisions. This article will help you to either explore cardiovascular coding or update your coding know-how for this specialty.

The 2020 CPT code updates by the American Medical Association (AMA) include 394 code changes, including 248 codes, 7 deletions and 75 revisions. Cardiology has 26 new codes and 11 deleted codes. Pacemaker Removal : Code 33275 , leadless pacemaker removal, was revised to include imaging guidance

Essential Tips for Handling Cardiology Coding and Billing

A stress CTP study should be reported using CPT® code 75574 (Computed tomographic angiography, heart, coronary arteries and bypass grafts (when present), with contrast material, including 3D image post-processing (including evaluation of cardiac structure and morphology, assessment of cardiac function, and evaluation of venous structures, if performed) and one of the appropriate cardiac stress codes (93015-93018).

CPT® Codes and Physician Reimbursement Medicare Part B pays for physician services based upon the Medicare Physician Fee Schedule (MPFS). Fee schedule amounts are calculated according to the Resource-Based Relative Value Scale (RBRVS), which is updated each year. Procedures are reported using CPT® codes.
