Under the authority of South Dakota state law , administrative rules , and FIFRA, the SDDA trains, certifies, and licenses pesticide applicators, and licenses pesticide dealers. Commercial Applicators. Generally speaking, if you apply pesticides for hire or are a government employee that applies pesticides while performing your work duties, you must have a commercial applicator license. You are considered a commercial applicator if: Engage in the business of applying pesticides to the lands ...

Pesticide Applicator and Dealer ... - South Dakota

Commercial Applicator License's and category certification is valid for 2 years. License and category certification renewal is required biannually. A fee of \$25 is required at the time of renewal. However, government employees are exempt from the fee. In order to apply pesticides as a commercial applicator you must be certified in the particular category that applies to the purpose of your application.

The South Dakota Department of Agriculture (SDDA) will offer an online commercial applicator test for commercial applicators who need certification and a temporary license for the 2020 season. Applicators who pass the online exam will be issued a temporary commercial applicator license valid through September 30, 2020.

To apply for your South Dakota CDL or Commercial Learner's Permit (CLP), you'll need to have a valid South Dakota Driver License and a few other things:
Completed license application form
Other required documents and a completed medical certificate form (if applicable)
\$33 application fee (plus \$15 for each endorsement test)
