In the United States, crime rates are measured in one of two ways. (1) The Uniform Crime Report, administered by Federal Bureau of Investigation, compiles data of crimes reported to local police. The UCR was established in the early 1930s. Because it is based on local information, the UCR permits statistical analysis for local areas.

Crime statistics emerged in the early nineteenth century as an adjunct to the administration of justice, the primary purpose being the measurement of the
