The exception to this is the cross-border merger regime, derived from the European Union Directive 2005/56/EC (as subsequently repealed and codified by Directive 2017/1132/EU), which was implemented in the UK by The Companies (Cross-Border Mergers) Regulations 2007 (as amended) (the "CBMR"). Under the CBMR, a merger of one or more UK companies can be completed, providing the merger is with at least one company from a different EEA state.
