Note that a person could be both a shadow director and a de facto director, eg if they assume the functions of a director as regards one part of the company's activities and gives directions to the board in relation to a different part of the company's activities.

A shadow director is someone who is not appointed as a director but who gives directions or instructions that the directors of the company are accustomed to act upon. A person however is not regarded as a shadow director solely because the company directors act on the advice given by that person in a professional capacity.

A de facto director is someone who fulfils the role of director without being formally appointed. A shadow director, on the other hand, is someone who makes decisions behind the scenes.

De facto or shadow directors - Blackhawk

The term De Facto Director is very closely associated with Shadow Director and is described as someone who is a director in everything but shown on Companies House. This is also the same for someone who refers to themselves as a Director of the company; they may be involved in key negotiations and be the face of the company.

De Facto, De Jure and Shadow Directors – Which One Are You ...

The day to day running of a company or a business is often overseen by a person who has not been formally appointed as a director, and many people believe that unless you have been formally appointed you will not owe the usual directors' duties to your company. This is not the case. Directors that have not been formally appointed, often referred to as de facto directors or shadow directors, will also be bound by certain duties.

A shadow director is a person whose instructions and decisions the other directors accept and implement unlike a de facto director he may not carry out those actions himself [Note 7]. A shadow...

The High Court has, in Ultraframe (UK) Ltd v Fielding and others, considered the statutory definition of shadow director and expressed the view that a person at whose direction a governing majority of the board is accustomed to act is capable of being a shadow director, and that the mere fact that a person falls within the statutory definition of shadow director is not enough to impose on him the same fiduciary duties as are owed by a de jure or de facto director.

Are shadow directors liable in an insolvency procedure?

Such persons (who may be individuals or companies) are known as "shadow" and "de facto" directors. Although both are types of person who exercise influence over a company without being validly appointed as directors, the categories are separate and in most cases mutually exclusive.

Shadow and de facto directors - a reminder of the risks

Note that the duties owed by de jure directors at common law and imposed by Section 170(1) of the Companies Act 2006 apply to de facto directors too who are therefore subject to the same duties. There are few cases in which shadow directors fiduciary duties are considered.

A de facto director is a person who the company has not officially appointed as a director. However, they still act as if they were in the position of a director. Therefore, a court may still recognise you as a de facto director if your actions indicate this to be the case.
