On May 11, 2016, President Obama signed the Defend Trade Secrets Act of 2016 ("DTSA"), creating a federal private civil action for the misappropriation of trade secrets. The DTSA does not preempt state law but provides an additional forum for relief.

Defend Trade Secrets Act: A New Era in Intellectual ...

The Defend Trade Secrets Act of 2016 (DTSA) was signed into law by former President Obama and became effective on May 11, 2016, amid much fanfare. At the time of its passage, the law was described as the "most significant expansion" of federal law in intellectual property since the Lanham Act in 1946. The DTSA provided a federal cause of action for trade secret misappropriation.

The Defend Trade Secrets Act: One Year Later

In 2016 the Federal Government adopted a similar set of laws under the Defend Trade Secrets Act (DTSA), codified at 18 U.S.C. §1831-1839. The UTSA and the DTSA are similar but differ in some key respects.
