These bye-laws, which have been revised after a gap of 33 years, were announced by the Urban Development Minister M. Venkaiah Naidu here on Wednesday.

New building bye-laws for Delhi notified. In a move that could benefit home buyers, the Delhi government has notified the new building bye-laws and plans to create a centralised form for obtaining building permits. Delhiites will be now able to get a building plan approved within 30 days, and no construction permission will be needed for plots up to 105 sq metres in the national capital, under the new building bye-laws notified on June 6, 2016.

Building Bye-Laws are legal tools used to regulate coverage, height, building bulk, and architectural design and construction aspects of buildings so as to achieve orderly development of an area. They are mandatory in nature and serve to protect buildings against fire, earthquake, noise, structural failures and other hazards.

APPLICABILITY OF THE BYE-LAWS. 3.1 In addition to the provision of Delhi Development Act, 1957, the building bye-laws shall apply to the building regulation, activity, in the Union Territory of Delhi under the jurisdiction of the Delhi Development Authority as given in clause under 3.2 to 3.6. 3.2 Where a building is erected, the Bye-law applies to the design and construction of the building. 12
