If you cannot complete an application online or by email, you can ask Disclosure Scotland for a paper application form. This takes longer, so try to apply online or by email first. Email response@disclosurescotland.gov.scot to get a paper form. Include your: name; address details; the number and type of application you need

## Request a disclosure application form - mygov.scot

Applications for basic disclosure will be processed according to the Scottish rules under the Rehabilitation periods for particular sentences section of the Rehabilitation of Offenders Act 1974. Disclosure Scotland doesn't monitor people with basic disclosure, so the certificate is only valid when it's created and not for a specific length of time.

## Disclosure and criminal record checks - mygov.scot

You must use a paper form: if you are applying to register your organisation with Disclosure Scotland; to add or remove a countersignatory. Email response@disclosurescotland.gov.scot to get paper forms. Include your: name; address details; the number and type of application or form you require

## Get a paper PVG form or guidance documents - mygov.scot

Get a paper disclosure application form. Form to request a paper application for basic, standard or enhanced disclosure from Disclosure Scotland. Help with the basic disclosure online application. #### Disclosure in Scotland - mygov.scot

If you live outside the UK, you will need to apply using a paper application form. The address you enter will show on your certificate. This is also where your certificate will be sent. You should enter your current home address, or other UK address where you want the certificate to be sent, for example, a Halls of Residence.

## Help with the basic disclosure online application - mygov.scot

Applying for standard disclosure If you need a standard disclosure, you'll apply through your employer or another registered body on their behalf. They'll give you either a paper or digital form to complete which they then send back to Disclosure Scotland. > You have to be a registered body to apply for standard disclosure.

## Standard disclosure - mygov.scot

When you apply for any type of disclosure, the certificate is sent to the address you put in your application form. Certificate returned to Disclosure Scotland by Royal Mail If you want a certificate sent to a different address to the one shown on your certificate, ask Disclosure Scotland for this in writing.

## Get a copy of a disclosure certficate - mygov.scot

If you want a basic disclosure for personal reasons rather than work purposes, apply where you live — Disclosure Scotland (this service) if you live in Scotland, or the Disclosure and Barring Service if you live in England or Wales. Apply online Before you start. You must do your own basic disclosure application. What you need for your online application. You'll need the following information to hand before you start your online application: your address details for the past 5 years

## Basic disclosure - mygov.scot

Most people who need an enhanced disclosure apply through their employer. They'll give you a paper or digital form to complete which they'll then send back to Disclosure Scotland. You have to be a registered body to apply for an enhanced disclosure. Alternatively, you can use an umbrella body to make your disclosure applications for you.

## Enhanced disclosure - mygov.scot

You can ask for a PVG application form to be posted to you. Paying for a PVG. It costs £ 59 to join the PVG scheme for most roles in all sectors. The organisation you're applying for will tell you if you need to pay the joining fee or if they'll pay for it. Some workers can get a free disclosure.

#### DBS Forms and Guidance - Due Diligence Checking Ltd

Apply for a basic Disclosure and Barring Service (DBS) check to get a copy of your criminal record. This is called 'basic disclosure'. It costs £ 23. It's available for people working in England and...

#### Request a basic DBS check - GOV.UK

Disclosure Scotland works within a Service Level Agreement to produce 90% of all types of Disclosure, for a correctly completed application with no further enquiries, within 14 calendar days. This is measured from the day we receive the application to the day of dispatch. Certificates are dispatched 1st class Royal Mail postage.
