A duty to rescue is a concept in tort law that arises in a number of cases, describing a circumstance in which a party can be held liable for failing to come to the rescue of another party who could face potential injury or death without being rescued. In common law systems, it is rarely formalized in statutes which would bring the penalty of law down upon those who fail to rescue.

No Duty to Rescue. At common law and in most states, people, generally, have no duty to help or rescue another person. You would only have a duty to help if you created the peril, you started trying to rescue or help, or you have a special relationship, such as parent-child, with the person in need.
