For many ISO Certified Management Systems, a well-maintained Internal Audit schedule is a requirement of compliance against the Standard.

Pay attention – Don't allow people to be checking texts or looking at their computers during the audit (unless it's part of the audit to get information). Mute when necessary – Learn the power of keeping background noise to a minimum (and any undesirable, off-hand comments, too).
