Landlord Tenant Rights. According to Connecticut law (Connecticut General Statutes Title 47a), a lease can be written or oral. Wherever there is a valid lease in Connecticut, the law automatically grants certain rights and privileges to tenants, such as the right to a habitable dwelling and the right to seek out housing without discrimination. Landlords also have certain rights, such as the right to collect rent in a timely manner and the right to deduct for damages to property that exceed ...

Nonpayment of rent ¶ If a tenant misses a rental payment, landlords must give a 7-day pay notice. Failure to pay within this 7-day window can be grounds for eviction. Violation of lease terms ¶ If a tenant violates a lease, landlords must provide a 14-day notice requesting they remedy their behavior. Landlords can then file a 7-Day Additional Quit Notice before filing for eviction with a court.

Landlord Tenant Rights In Pennsylvania, a lease agreement exists wherever a tenant agrees to exchange rent for inhabiting a property. According to Pennsylvania law (Pennsylvania Landlord and Tenant Act), tenants have certain rights, such as the right to enjoy the property without undue disturbance and the right to a habitable living space.

According to Illinois law (IL Landlord and Tenant Act), any lease agreement carries certain rights and responsibilities for both tenants such as the right to seek habitable housing. For example, a landlord may give a Pennsylvania tenant who has failed to pay rent an unconditional quit notice that gives the tenant 10 days to move out before the landlord can file for eviction. In Michigan, oral and written leases are allowed, but leases longer than 1-year must be in written form to be valid. Michigan law (Landlord and Tenant Relationship Act 348 of 1972) grants tenants certain rights like the right to the return of a security deposit and the right to a habitable dwelling. Landlords have rights too, including the right to collect rent and the right to be reimbursed for damages that exceed normal wear and tear.
