Public Safety Dispatcher Selection Standards

As set forth in M.C.L. 484.1413 (1)(b), the Michigan Public Service Commission (MPSC) has established administrative rules mandating all primary Public Service Answering Points (PSAP, the point where the 911 call is answered) across the State of Michigan maintain a minimum training standard for every Telecommunicator (those persons answering 911 calls and dispatching public safety units to the scene).

" Dog grooming was a lot of physical, manual labor where I had to sometimes wrestle dogs that weighed more than I did," she said. " When I moved to Albuquerque with my husband in 2015 so he could enter the police academy there and I just wanted something to get me on the same schedule and give me a better understanding of what he does and what I could do, so I went into dispatching. "
