## *Public rights of way - Highways and footpaths - Planning ...*

In legal theory most paths become rights of way because the owner “dedicates” them to public use. In fact very few paths have been formally dedicated, but the law assumes that if the public uses a path without interference for some period of time – set by statute at 20 years - then the owner had intended to dedicate it as a right of way.

A private right of way is an easement, which is the right to use part of another's property in a particular way even though they do not own it. There are four main categories of easements (or rights), over an adjoining parcel of land. These are rights of way, rights of light and air, rights of support and rights relating to artificial waterways.

## *Private Rights of Way*

Right of way is "the legal right, established by usage or grant, to pass along a specific route through grounds or property belonging to another", or "a path or thoroughfare subject to such a right". A similar right of access also exists on land held by a government, lands that are typically called public land, state land, or Crown land. When one person owns a piece of land that is bordered on all sides by lands owned by others, an easement may exist, or be created so as to initiate a right of w

Implied Right of Way – The Law of Property Act 1925 confirms that, when a property is sold, the land will include the benefits of any existing rights of way. Prescription Right of Way – After continued use over a prolonged period of time a right of way used can become recognised and legitimate.
