A family office is the organization a family creates, often after the sale of a family business or another significant liquidity event, to support the financial needs of a specific family. Every family office is as unique as the family it serves.

In its most general form, a family office is a wealth manager created by a family to meet its unique wealth and investment needs. 1 Family office investment services include asset allocation and third-party investment manager selection at a minimum, and larger family offices sometimes offer internal investment management as well. The first hire is oftentimes a chief investment officer (CIO), who, for smaller family offices, often serves as the day-to-day CEO as well.
