As of February 2018, 173 countries have ratified the United Nations Trafficking in Persons Protocol, of which UNODC is the guardian. Significant progress has been made in terms of legislation: as of 2012, 83% of countries had a law criminalizing trafficking in persons in accordance with the Protocol.

As to the international criminal nature of trafficking in persons, the U.N.S.C. has underscored that " acts or offences associated with trafficking in persons in the context of armed conflict may constitute war crimes ", condemning in particular " trafficking in persons and violations and other abuses committed by Boko Haram, Al-Shabaab, the Lord ' s Resistance Army, and other terrorist or armed groups for the purpose of sexual slavery, sexual exploitation, and forced labour. "

Trafficking in persons means the recruitment, transportation, transfer, harbouring or receipt of persons by means of the threat or use of force or other forms of coercion of abduction, fraud of deception of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over
