Most tribal nations, therefore, have their own tribal law enforcement as well as tribal courts. Most Native American tribal nations have their own law enforcement. The relationship between the federal government, state governments, and tribal governments within the United States is complicated at best. Jurisdiction over a crime or lawsuit will depend on the tribe in question, the crime or basis of the lawsuit, and whether or not the parties involved are Native American or non-Native American.
